# JULIAN R MURPHY

Julian has appeared as lead and junior counsel in jury trials, appeals, committals, voir dire proceedings, interlocutory applications, bail applications, sentencing hearings and mental impairment/fitness detention and supervision proceedings.

In his written advocacy, Julian has authored successful written applications in the High Court as junior counsel, including amicus curiae and special leave applications. Julian also co-authored what was reported to be the Northern Territory's first successful mercy petition – for an Indigenous man convicted of murder.

Prior to coming to the Bar, Julian worked as the Criminal Appeals Manager at the North Australian Aboriginal Justice Agency and as a Judge's Associate at the High Court of Australia.

Julian holds an LLM from Columbia University, where he graduated first in the class, and is now a PhD candidate at Melbourne Law School, where his research focuses on constitutional law and statutory interpretation. Julian has authored numerous scholarly articles and is co-author of the forthcoming third edition of

Criminal Laws Northern Territory (Federation Press, 2021).

He acted as counsel for the Secretary-General in litigation and arbitration in administrative, human rights, criminal, commercial, and tort law matters.

He has also been the lead advisor on specific investigations to the former Chief Justice of Tanzania and Chief of Prosecutions of the Rwandan War Crimes Tribunal.

Simon is also admitted to the Bar in New York and holds law degrees from Monash University and the University of Melbourne, for which he has received scholarships and honours respectively. He has a long history of volunteering and is on the Executive Committee of the International Commission of Jurists (Victoria).
